SUBJECT: Default & Secret Abdication.-- Two OUTCOMES --- the fact that HRMQE2 abdicated the accession of the British Christian Throne--and that by Operation of Law, she hasn't acted as Queen since June 6, 1953--and moreover--that The Crown has institutionalized crimes of personage and barratry being practiced against Peoples of the United Kingdom--- are part and parcel of the FACT--*Britain hasn't had a lawful Queen or government for the better part of a hundred years.*

Your Honors--

We have proven reason to believe that her Royal Majesty, Elizabeth, Queen of the United Kingdom, did secretly and in Bad Faith abdicate the Christian Throne three days after her Coronation, that she knowingly broke all promises provided as assurances to the people of the United Kingdom, that she willingly chose to occupy The Chair of the Estates instead and has remained in that undisclosed office throughout her reign.

We hereby object to this Breach of Trust and Contract in the name of the same people of England, Scotland, Ireland, Wales, and the Territories thereof: we, the people of these lands, agreed to be bound to a Christian Monarch, a role and an office that Elizabeth II abdicated without Notice as of June 6, 1953.

We have also discovered that as part of the World War II Ministry headed by the then-Lord President of the Privy Council, the people of the United Kingdom were all deemed to be incorporated franchises of The Crown, deprived of their natural standing and status as living people, and unlawfully converted via falsification of public records into PERSONS representing their Christian Names and Estates on paper. This unholy practice of personage and its enforcement by barratry under the Cestui Que Vie Act of 1666 are acts of inland piracy and press-ganging which have been universally recognized as crimes for 200 years. We demand that these practices cease and desist and do not allow any pretension that this has been done via fully disclosed and knowing contractual consent of the victims.

As the Queen has vacated her Office and her Coronation Oath any allegiance to her and her Government is severed by Operation of Law effective June 6, 1953. The British Monarchy, such as it is, still stands in the person and DNA of Emily Windsor-Cragg, who has served the obligations of a Christian Monarch in the face of all these adversities. It is in literal fact a matter of whom you will serve --- either Jesus or Baphomet.
